1. The qualification and experience required for teaching posts will be as per “UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018 and its subsequent amendments. However, Ph.D. in relevant field is desirable.
2. For faculty positions of Department of Computer Science & Technology, minimum eligibility conditions will be as per AICTE 2019 regulations and its amendments from time to time
3. For faculty positions of Department of Pharmaceutical Sciences and Natural Products, minimum eligibility conditions will be as per Pharmacy Council of India (PCI) Regulations issued from time to time. Further, the candidate must be registered Pharmacist.

10. The right is also reserved with the university either to fill or not to fill the vacancies. The decision of Competent Authority of the university in this regard shall be final.
